



CONTEST

TERMS AND CONDITIONS

These terms and conditions of use constitute a legal agreement between you, the Miami Street Photography Festival (MSPF) and its affiliates (Street Photo Milano). Upon submission of images, you agree to be bound by the terms and conditions of this agreement.

ELIGIBILITY

Entrance is open to ages 18 and over and residents of all countries.

TIMING TERMS

The MSPF ITALY PHOTO SERIES PHOTOGRAPHY CONTEST begins January 19 at 12:00 a.m. Milan Time and ends Tuesday March 20, 2018, h. 23:59. By submitting an entry, each entrant agrees to the Official Rules and warrants that his or her entry complies with all requirements set out in the Official Rules.

REQUIREMENTS

By entering the contest, entrant acknowledges, represents and warrants that the submitted work is original and authored by the entrant and agrees that the submitted photograph does not infringe on the copyrights, trademarks, moral rights, rights of privacy/publicity or intellectual property rights of any person or entity, and that no other party has any right, title, claim, or interest in the photograph.

Any work from another artist included in the image must only be a component of the frame, and not the subject.

Submitting an entry does not guarantee inclusion in the festival's main exhibition.

Published, as well as unpublished work is acceptable, as long as entrant maintains copyright privileges.

Images that have not received awards in other festivals are encouraged.

All photos must comply with basic tenets of appropriate content. No defamatory, sexually explicit, obscene, or abusive subject matter will be accepted.

ENTRY FEE

Each series of images (3 to 7) = € 50.

Entrant can pay through PayPal or with a credit card.

JUDGING

There are two rounds of judging. In the first round all submissions will be judged in a blind-juried contest. The judges will select up to 10 finalists.

In the second round of voting the top three winners will be selected from among all the contest finalists.

The 2018 judges include [Nick Turpin](#) and [Alessandro Penso](#). Final panel to be announced soon.

FINALISTS

Selected Finalists will be asked to send a high-resolution jpg. file (250-300dpi) of the entered image.

Printing/Mounting/Framing of finalists' images for the exhibition will be provided by MSPF and Street Photo Milano at no extra cost to participants.

All images remain the creative and intellectual property of the author. The Miami Street Photography festival and Street Photo Milano fully supports the rights of photographers.

AWARDS ANNOUNCEMENT

The top three winners, the Public Choice winner and the prizes will be announced at the evening award presentation.

Award winners do not have to be present to receive the recognition.

PAYMENTS

All payments of submitted images are non-refundable.

LICENCE

By entering the contest, entrant grants the Miami Street Photography Festival and its affiliates (Street Photo Milano) worldwide permission to utilize the submitted image, and the entrant's name and likeness, for promotional purpose in connection with the Contest and promotion of the contest, including, but not limited to: online/print media, exhibition of finalists/selected entries, publication of a book featuring selected finalists/selected entries for up to 5 years after submission of the image. The Miami Street Photography Festival and its affiliates (Street Photo Milano) will not be required to pay any additional compensation in connection with such uses. The photographer will always be credited, and at no time will the submitted image be used for commercial purposes.

LIMITATION OF LIABILITY

By participating, entrants agree to release, discharge, and hold harmless the Miami Street Photography Festival, Street Photo Milano, all respective partners, affiliates, subsidiaries, advertising agencies, agents and their employees, officers, directors, and representatives from any claims, losses, damages, and injuries arising out of their participation in this festival. You agree to fully indemnify MSPF with respect to all royalties, fees and any other monies owed to any person or entity. The Organizers (MSPF, Street Photo Milano and all affiliates) assume no responsibility for any error, omission, interruption, deletion, defect, or delay in operation or transmission; communications line failure; theft or destruction of or unauthorized access to festival entries or entry forms; or alteration of entries or entry forms. The Organizers are not responsible for any problems with or technical malfunction of any telephone network or lines, computer online systems, servers or providers, computer equipment, software, failure of any e-mail entry to be received on account of technical problems or traffic congestion on the Internet or at any website, human errors of any kind, or any combination thereof, including any injury or damage to entrants' or any other persons' computers related to or resulting from participation, uploading, or downloading of any materials related to this festival.
